## May 19<sup>th</sup> 1866 – Brentsville Court

At a Circuit Court continued and held for Prince William County at the Courthouse of said County on the 19<sup>th</sup> day of May 1866.

Hon: Henry W. Thomas, Judge

The Court doth appoint Dr. Colin H. Lambert physician to attend the prisoners confined in the jail of this County.

An account of Robert Renoe against the Commonwealth amounting to one hundred and seventy eight dollars, for acting as guard for the jail of this County, was presented to the Court, and it appearing to the Court that Hon: E. K. Snead the former Judge of this Court appointed said Renoe as such guard, and it further appearing to the Court that said guard was necessary, not because of the insecurity of said jail, but for other reasons, set forth in the report of A. Nicol a special commissioner appointed to examine said jail. Said account is allowed by the Court and ordered to be certified to the auditor of public accounts for payment out of the treasury.

An account of Henry Holland against the Commonwealth amounting to one hundred and seventy eight dollars, for acting as guard for the jail of this County, was presented to the Court, and it appearing to the Court that Hon: E. K. Snead the former Judge of this Court appointed said Renoe as such guard, and it further appearing to the Court that said guard was necessary, not because of the insecurity of said jail, but for other reasons, set forth in the report of A. Nicol a special commissioner appointed to examine said jail. Said account is allowed by the Court and ordered to be certified to the auditor of public accounts for payment out of the treasury.

An account of Colin H. Lambert M.D. for medical attendance on prisoners confined in the jail of this County, against the Commonwealth amounting to fourteen dollars was presented to the Court, and it appearing that said Lambert had not been appointed physician to said jail but the Court being satisfied that the medical service set out in said account was rendered and that they were proper, doth allow said account & ordered the same to be certified to the auditor of public accounts for payment out of the treasury.

The Court doth make the following allowances for public services to be paid out of the treasury as follows to wit:

To A. Nicol attorney for the Commonwealth in this Court	\$25.00
To John Camper, Clerk of this Court	\$15.00
To F. J. Cannon, Sheriff of this County	\$10.00
To Charles Wright jailor of this County	\$15.00
To Charles Wright jailor of this County for attendance on the Courthouse	
Six days at the rate of two dollars per day.	\$12.00

An account of Charles Wright jailor of this county against the Commonwealth for dieting prisoners since they were remanded to this court for trial by the County Court, amounting to three hundred and sixty five dollars and a half was presented to the court, examined, allowed and ordered to be certified to the auditor of public accounts for payment out of the treasury.

John Smith alias McGibbony who stands indicted of horse stealing, William Johnson and Thomas Jennings who stand indicted of horse stealing, George Savage alias Crouch and Wileman Cornwell who stand indicted of Grand Larceny were led to the bar in custody of the jailor of this County and being demanded severally of them, if anything they knew or had to say, why the Court should not proceed to pronounce judgment against them and nothing being offered in delay of judgment it is ordered that the said John Smith alias McGibbony be confined in the Penitentiary of this State for ten years, and that the said William Johnson, Thomas

Jennings, George Savage alias Crouch and Wileman Cornwell be confined in the Penitentiary for the term of five years, each. And it is ordered that the Sheriff of this County do as soon as possible after adjournment of this Court remove and safely convey to the said Penitentiary of this State the said John Smith alias McGibbony, William Johnson, Thomas Jennings, George Savage alias Crouch and Wileman Cornwell, therein to be kept confined and treated in the mode prescribed by law.
